A discussion followed on new destinations and distances. We could run on road as well as off road rides. One thought is that we should offer some longer rides on road of say 15 miles each way, with a rest after 7miles. This would help people to make the transition between our short rides and the longer ones run by CTC Clubs and the 40+ Group. Other suggestions included -

Planning, Infrastructure, and Locality Budgets

Bridge Road, Heronswood Rd, Howlands, WGC on road scheme. A discussion followed with maps of the route. The main points were -

- The scheme uses a busy main road and main bus route.
- The north end does not join with the town centre
- The south end does not join with Ascots Lane and NCN 12.
- The route makes no use of guiet roads.
- Paint on road (in isolation) does nothing for motorists behavior and speed.
- It is extremely unlikely that Sustrans have been properly involved.

Adam offered to draft a response to Clare Martin, Herts Highways. Action Adam. Done

Campus East Offices Development. At least 4 responses were sent to the WelHat Planning Portal.

Our main objection is that the Travel Strategy and Environmental Checklist docs make claims that the offices are well served by cycle paths when in reality there are no paths.

Welhat Planning Alert System. After registration residents can receive weekly email notifications of planning applications in their area. There should be an option to choose alerts on large scale developments. http://www.welhat.gov.uk/index.aspx?articleid=5371 It may be possible to set up notifications for more than one area but this may need multiple email addresses.

On the subject of consultations and lobbying for cycling infrastructure, it will be more effective to put in multiple responses. To do this: when anyone sees anything relevant, email the group so we can respond individually. Then if we feel it is really important and that there is enough time before the deadline, we will consider writing a WHCF response.

It was noted that not everyone has the time to respond individually. Also, having seen the main response others can pick up on the important points and comment individually.

Finances

WHBC have introduced a 'Community Chest' scheme for small clubs and societies. Roger will email Councillors requesting small donations. **Done**

Herts Speed Management Consultation

The proposed new Hertfordshire Speed Management Strategy document is generally very good, but an anomaly was found regarding 20mph limits. For all speed limits over 20mph, the Maximum Mean Speeds after implementation is shown as the respective Speed Limit. However, the Maximum Mean Speed after implementation for 20mph is shown as 24mph, which is only 1mph less than the Maximum Mean Speed shown before implementation. It doesn't seem worth bothering for so little speed reduction, especially since this could still mean many cars travelling at 30mph.
